## LEGAL TERMS

When all the definite details of your registration are agreed on, you will receive the invoice and updated plant featuring your location. The payment thereof must be performed within the established deadlines.

With this registration the company acknowledges and accepts the Rules of Participation for Exhibitors of Kikai Eventos, governed by the [General Regulation of Fairs and Exhibitions and Technical Regulation of Exponor – Feira Internacional do Porto](#), intended to manage its relationship with Kikai and its participation in the fair. By providing your data, you expressly consent the use of such data to perform periodical communications, including by electronic means, to inform you about the activity of the fair, such as activities, contents and services. Consequently, you consent that your professional data (trade name of the commercial name, address and e-mail, telephone number and fax, and contact person) may be communicated, having to remain confidential, to companies working with Kikai, providing ancillary and value added services to it, with the purpose of updating you regarding information about its activities and services. The rights of access, rectification, objection and withdrawal regarding these data can be exercised through a letter addresses to Kikai or via email to [geral@kikai.pt](mailto:geral@kikai.pt).

Please help us to keep the data updated by communicating us any changes thereto.

In case of force majeure, the Organiser may suspend fulfilment of his contractual obligations with Exhibitors during the period the cause of force majeure subsists, or terminate completely or partially contracts at any time with immediate effect, meaning that under no circumstances, shall the Organiser be liable for compensating Exhibitors. If the event is cancelled, delayed or interrupted by an unforeseen event or force majeure, the Organiser, shall be held harmless of liability and the amounts paid by Exhibitors may be retained by the Organiser to ensure no claims for damages are made or the credits will be transferred for a future event celebration. In this sense, the Exhibitors accept full, exclusive liability for the event, and cannot claim any compensation for loss and damages or any other reimbursement action.

Reservations may not be unilaterally cancelled or modified by the Exhibitor. Cancellations must be made by verifiable communication to the Organiser. Requests for reduction of space allocated to the Exhibitor in the stands will be considered and treated as cancellations. If the contract is cancelled, for whatever reason, the following rules apply: (i) if the cancellation occurs 30 days or more before the date of the Exhibition, the Exhibitor shall pay as compensation an amount equal to 100% of the agreed price and (ii) If the Exhibitor does not occupy the stand, the Organiser may decide, at his discretion, to offer the stand to another Exhibitor. (iii) If, for any reason beyond the control of the Organiser (including but not limited to, any action of the event owner, strikes or other labour contingency affecting Organiser's staff), the date or location of the event must be changed, the Organiser may elect at his sole discretion to: a) cancel, b) change the location and date of all or part of the event, c) terminate or change the organisation of the event, d) reduce the period for preparing the event, and all this without the right of return of the price paid by the Exhibitor. Under no circumstances shall the amount of the refund to the Exhibitor exceed the price paid by the Exhibitor.
